


Anti- Ragging Committee

If any complaint is received in this regard by the committee, it will be dealt with very strictly. A fine will be imposed on the student(s) if he/she is found guilty by the committee. The student(s) involved in ragging may be debarred from the class and even rusticated/expelled from the institute, depending upon the nature and gravity of the offence as per the instructions mentioned in Appendix 12, Clause 12.6 of the AICTE Handbook.




